Review Agenda

Agency Financial Report

Ms. Mok updated the Commission about the FY2020 victim payment budget position for the period of July 1, 2019 to November 20, 2019. The agency started the fiscal year with the beginning budget of \$2,620,585. The total amount for victim payouts to date is \$951,197, and leaving an available year-end balance of \$1,669,388.

Ms. Mok updated the Commission on the status on Crime Victims Fund. The agency received a total of \$328,512 in Crime Victim Fund for the period of July 1, 2019 to October 23, 2019, which broke down by type as follows:

Restitution: \$26,494 Corrections: \$182,539 Civil Settlement: \$1,123 Penalty Assessment: \$118,356 Total received: \$328,512

Business

Grants Department Updates

Ms. Garcia, Grants Bureau Chief, informed the Commission of the following:

The FFY2019 final quarterly VOCA Victim Assistance Performance Measurement Tool reports were reviewed, entered and submitted to the U.S. Department of Justice Programs on Friday, November 15, 2019.

A contract with the University of New Mexico has been executed to conduct a two-year research project on the Incidence of Sexual Assault on Individuals with Disabilities. This project is a result of a special appropriation for FY2020 and FY2021.

The Office for Victims of Crime held a Reginal VOCA Victim Assistance Administrators meeting in Santa Fe, New Mexico, November 6-7, 2019. Director Zubia, Moises Valdez, Compensation Bureau Chief, Cindy Mok, CFO and MaryEllen Garcia, Grant Bureau Chief attended and co-hosted this meeting.

Status-Agency Annual Audit, McCabe CPA Group, LLC

Director Zubia updated the Commission of the agency's FY 2019 annual audit. They exit conference for the audit has gone well. There are no findings. The final report will be sent to the Commission electronically when it is available. Director Zubia wanted to give credit to Ms. Mok, Ms. Garcia, and staff who have done an exceptional job to provide everything that was requested by the auditor.

Office for Victims of Crime (OVC) Site Visit

Director Zubia updated the Commission on the OVC site visit. The agency has responded to the VOCA Compensation site visit recommendation. Our rules and regulations states that unless the Commission approved, the agency is not allowed to include clothing as part of the funeral expenses. This issue was brought up to the Commission in which it had been allowed for the State Investigators to make the determination, as long as the expense is included within the six thousand dollars (\$6,000) threshold for funereal expenses. Director Zubia also informed the Commission that the agency has not received the site visit report for the VOCA Assistance, but a conference call has been scheduled for November 26, 2019 with the leadership of OVC. Director Zubia will keep the Commission updated.

Status- Office Expansion

Director Zubia gave a status on the office expansion. The leadership from the Facilities Management Division (FMD) of the General Services Department is scheduled to visit our office December 5, 2019 to assess the new office space. FMD does not like the agency to exercise the final five-years extension option, due to the concern of the long-term commitment. The landlord requested to exercise this option because he agreed to absorb all the tenant improvement cost for the expansion. The tenant improvement cost could be over the amount of \$60,000, which the agency does not have the budget to accommodate. Director Zubia will keep the Commission apprised to the office expansion.

Agency Personnel Matters

Director Zubia updated the Commission on personnel matters. We were assigned a new HR Consultant from State Personal Office (SPO), who is not familiar to our agency's processes and needs. In addition, we were informed by SPO that they will terminate their HR shared services with our agency as of January 1, 2020. SPO will be assisting agencies during this transition. They also advised agencies to start requesting funding for a new FTE to provide HR services. Since the administrative department will be having a new financial position this fiscal year, the agency will modify duties on this position to include the responsibility. Director Zubia will keep the Commission apprised to all personal matters.

Director Zubia introduced the Victim Advocate to the Commission, Bianca Olona-Elwell, she has a background in social work she did community school advocacy for a charter school. We are very excited to have her.

Executive Session

At 10:26 a.m., Commission Chair Lee made a motion to enter into Executive Session. Commission Vice Chair Edward seconded the motion.
