#### Review Agenda

## **Agency Financial Report**

Ms. Mok updated the Commission regarding the fiscal year end FY22 budget position report regarding victim payments for the period of July 1, 2021, through June 30, 2022. The victim payment budget started in the amount of \$2,482,658. The total amount of victim payouts as of June 30, 2022, is \$2,454,524. The remaining balance for the FY22 is \$28,135.

## FY22 AND FY23 Victim Payment Budget Position

Ms. Mok provided detailed information to the Commission for the FY2022 and FY2023 Crime Victim Fund Budget position report regarding victim payments for the period of July 1, 2022, through August 16, 2022. The victim payment budget+ started in the amount of \$2,308,200. The total amount for victim payouts as of August 16, 2022, is \$376,688. The remaining balance is \$1,931,512.

#### **FY24 Proposed Budget Request**

Ms. Mok presented the FY24 Budget Request Overview spreadsheet to the Commission. CVRC proposed an increase of \$4.4 million in State General Appropriation to support the increased demand of sexual assault and

human trafficking victim service programs, care and support for crime victims and CVRC personnel and operation costs. The FY24 budget request is due on September 1, 2022. Ms. Mok will provide update to the Commission at the next meeting.

## FY22 Agency Audit

Ms. Mok informed the Commission that CVRC will begin the agency FY22 audit which will be conducted by Baldwin Accounting and Consulting LLC. This audit is due to the State Auditor Office by November 1, 2022. The Commission will be apprised of the audit entrance and audit exit meetings.
