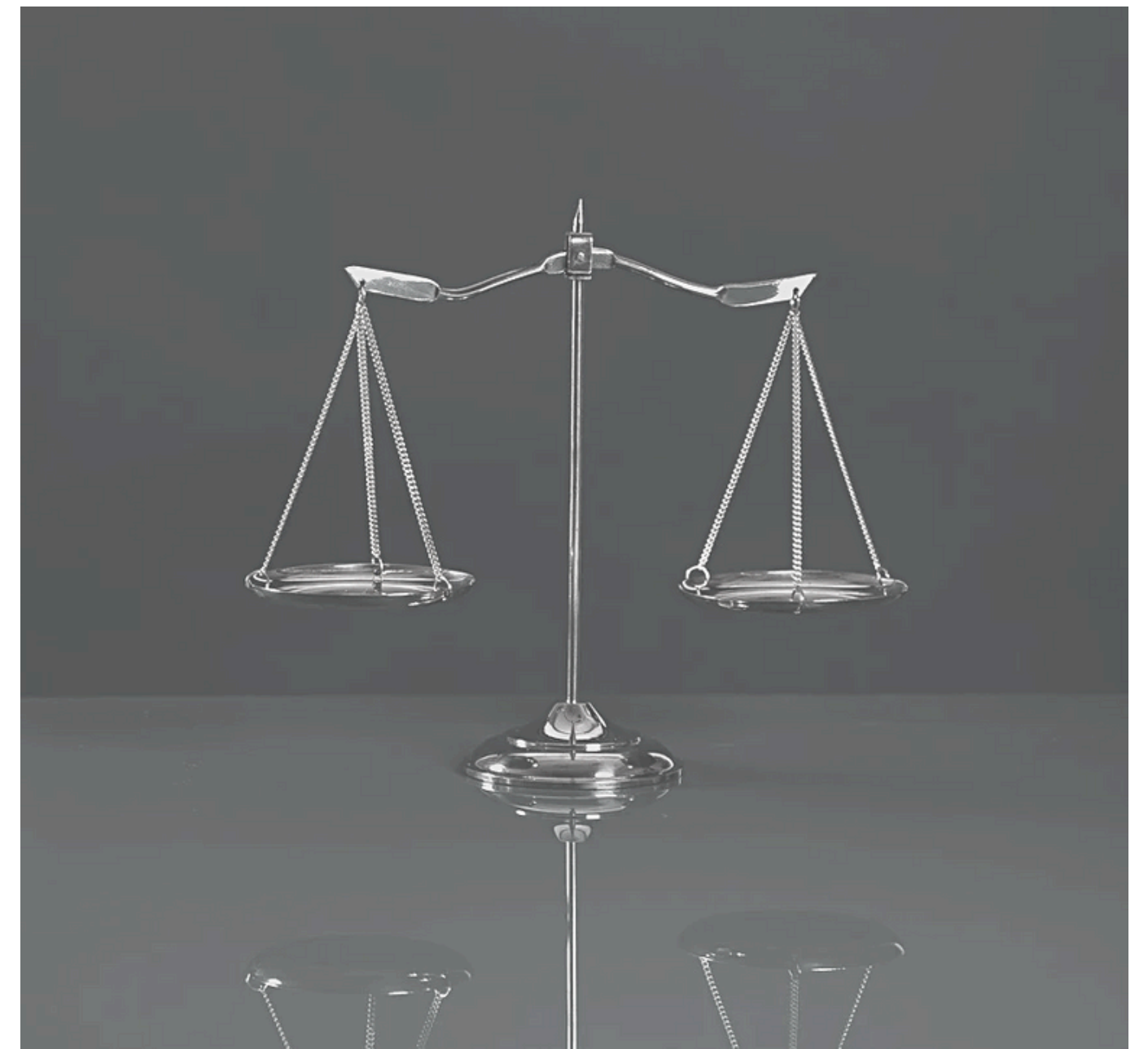

Primary focus of the project must be devoted to adults

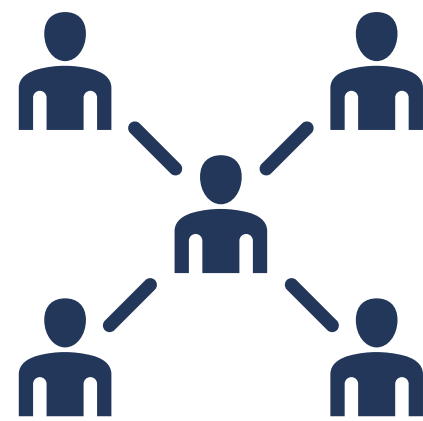
Services to children only as secondary victims or as primary victims if they are served as witnesses of domestic violence

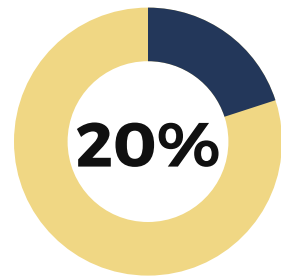

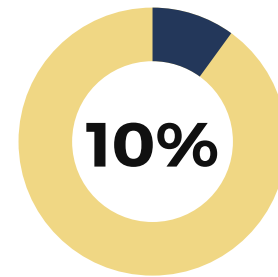

- Consult with community & governmental service providers
- Demonstrate coordination **during proposal development**
- **Minimum of 2 agencies**
- MDT/CCR regular meetings do **not** meet the criteria

- **No later than 4:00 PM Mountain Time**

Late Submissions Not Accepted

The CVRC Commission has determined that failure to meet this deadline is not grounds for protest; it is a mandatory requirement of the RFP process. Proposals received after this deadline will not be considered.



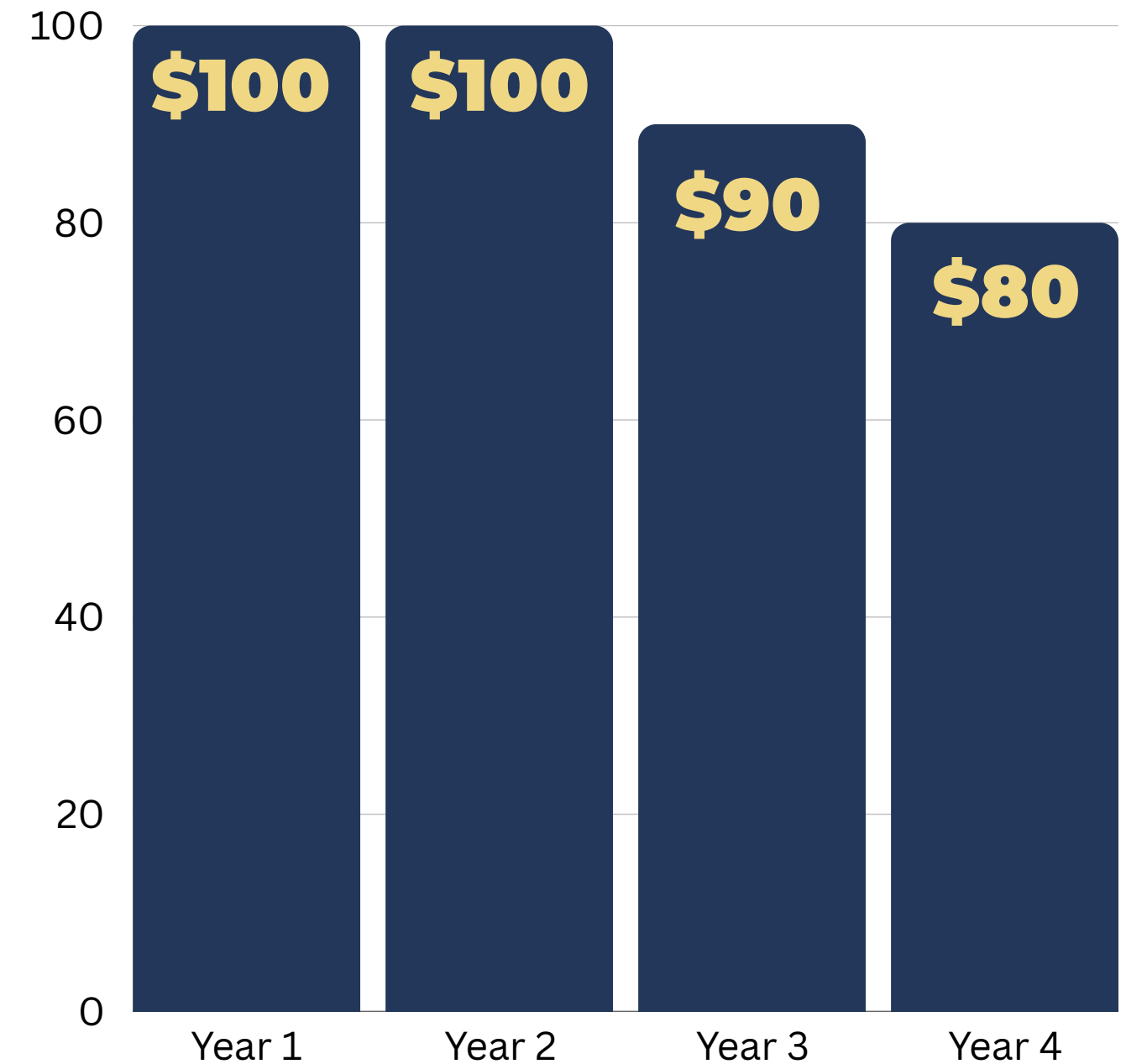
STOP VAWA Funding Strategy

Continuation Funds

- **4-year cycle**
 - Must maintain good standing
 - Non-recurring projects ineligible (conference, etc)
 - Submit continuation proposal for funding years 2-4
 - 5th year - Apply as new in competitive process
- **Yearly Budget Applications**
 - Year 1: Original award
 - Year 2: Original award
 - Year 3: 10% reduction of original award
 - Year 4: Additional 10% reduction of original award

The Violence Against Women Reauthorization Act of 2022 (VAWA 2022)

Federal Purpose Areas

- STOP VAWA proposals **must** fit within
 - **at least one of the 24 Federal Purpose Areas**
 - **the Goals and Objectives of the 2022-2025 Strategic Implementation Plan**

FEDERAL PURPOSE AREAS

VIOLENCE AGAINST WOMEN REAUTHORIZATION ACT OF 2022

Proposals requesting STOP VAWA funding must demonstrate how the project or program aligns with at least one of the following 24 VAWA 2022 Federal Priority Areas

- 1** Training law enforcement officers, judges, other court personnel, and prosecutors to more effectively identify and respond to violent crimes against women, including the crimes of domestic violence, dating violence, sexual assault, and stalking, including the appropriate use of nonimmigrant status under subparagraphs (T) and (U) of section 101(a) (15) of the Immigration and Nationality Act (8 U.S.C.1101 (a)).
- 2** Developing, training, or expanding units of law enforcement officers, judges, other court personnel, and prosecutors specifically targeting violent crimes against women, including the crimes of domestic violence, dating violence, sexual assault, and stalking.
- 3** Developing and implementing more effective police, court, and prosecution policies, protocols, orders, and services specifically devoted to preventing, identifying, and responding to violent crimes against women, including the crimes of domestic violence, dating violence, sexual assault, and stalking, as well as the appropriate treatment of victims including implementation of the grant conditions in section 40002(b) of the Violence Against Women Act of 1994 (34 U.S.C. 12291(b)).
- 4** Developing, installing, or expanding data collection and communication systems, including computerized systems, linking police, prosecutors, and courts or for the purpose of identifying, classifying and tracking arrests, protection orders, violations of protection orders, prosecutions, and convictions for violent crimes against women, including the crimes of domestic violence, dating violence, sexual assault, and stalking.
- 5** Developing, enlarging, or strengthening victim services programs, including domestic violence, dating violence, and stalking, developing or improving delivery of victim services and legal assistance to underserved populations, providing specialized domestic violence court advocates in courts where a significant number of protection orders are granted, and increasing reporting and reducing attrition rates for cases involving violent crimes against women, including crimes of domestic violence, dating violence, sexual assault, and stalking.
- 6** Developing, enlarging, or strengthening programs addressing the needs and circumstances of Indian tribes in dealing with violent crimes against women, including the crimes of domestic violence, dating violence, sexual assault, and stalking.
- 7** Supporting formal and informal Statewide, multidisciplinary efforts, to the extent not supported by state funds, to coordinate the response of state law enforcement agencies, prosecutors, courts, victim services agencies, and other state agencies and departments, to violent crimes against women, including the crimes of sexual assault, domestic violence, dating violence and stalking.



Eligibility

Applicants must be able to present their organizational capacity to complete the mandatory elements outlined within their proposal.

The New Mexico Crime Victims Reparation Commission has determined that applications will be ineligible for consideration if they are late, incomplete or fail any of the mandatory elements outlined within the Request for Proposal Solicitation.

VAWA Narrative

7 Topics

- **All topics are mandatory for competitive proposals**
- **Only #7 is mandatory for continuation proposals**

Topic 3 & Problem Statement

- Strong, persuasive presentation of the problem
- Clear, concise picture
- Backbone of the proposal. Must be supported by all other elements
 - Measurable objectives, implementing activities, evaluation activities
- **Weak problem statements indicate that the applicant organization may not understand the problem or is not prepared to have a positive impact on the problem**

VAWA Narrative Topic 3

Developing the Problem Statement

- What is the nature of the problem?
- Who else in your area is working on the problem?
- How many people are affected and to what extent?
 - How can you prove it?
 - What statistical evidence do you have to support your statements?
- How often does the problem occur?
- What is the current client utilization of services for your agency?
- What is unique or special about your region?
- What **impact** will the project have on the criminal justice system and the targeted geographic region?



Use Data to Substantiate Your Needs

- Current, accurate, relevant
- Quantitative
- Surveys
- Focus Groups

Primary Project Components (PPCs)

Goal Statement

- Directly relates to a demonstrated need, as identified in the problem statement.
- **Not** an ultimate societal goal.
- Follows logically from your problem statement.
 - It is not appropriate to talk about a reduction in domestic violence if your statement of the problem discussed the need and justification for civil legal assistance.
- **Example: Increase the number of domestic violence victims who receive legal assistance to obtain orders of protection in Catron county.**
 - Program goal relative to demonstrated community need & is a goal that one can control.
 - This is different than "Reduce the incidence of domestic violence in Catron County"

Primary Project Components (PPCs)

Measurable Objectives

- **Quantifiable statements that support the goal and specify what must be done to:**
 - Maintain, Increase, Decrease, Enhance, Improve
 - And by how many
 - The amount of change you expect
- **SMART Objectives are**
 - Specific, Measurable, Action-oriented, Realistic, Timebound
- **Tip**
 - If you use a percentage (e.g. increase the number of SA convictions by 20%), include the baseline of convictions in the problem statement, so reviewers understand what 20% represents.

Primary Project Components (PPCs)

Implementing Activities & Impact Evaluation Activity

- **Implementing Activities**
 - Activities you must do to carry out the objectives you stated
 - Should be listed within the timeline they will be performed
- **Impact Evaluation Activity**
 - How will you show the impact of your program, i.e. did you reach your objectives?
 - You can answer this question if:
 - You can prove that your implementing activities were carried out, and
 - You can measure the increase or decrease or other changes to the degree your objectives stated

Primary Project Components (PPCs)

Conduct 1 training per quarter at each of the local law enforcement agencies (Aztec, Bloomfield, Farmington and San Juan County) to educate at least 5 law enforcement officers.</p>	<p>1a. Develop a PowerPoint using best practices for law enforcement response to victims of sexual assault.</p> <p>1b. Collaborate with the Coalition of Sexual Assault Programs to approve training materials.</p>	<p>1a. Maintain copy of PowerPoints, agendas, sign-in sheets and evaluation forms electronically at agency</p>

Proposal Budget

Budget Development

- Does it support the problem statement?
- Does it support all activities in PPCs?
- Is it realistic?
- Is it rounded off?

Common Issues

- Proposed expenditures are not supported by PPCs and Narrative
- Unrealistic - too high or too low
- Exceeds the funding request limit
- Does not adhere to grant guidelines



Budget Expectations

- Use Budget Section in WebGrants
- Follow budget instructions
- Line item categories observed
- Round off requested amount, no cents
- Match is clearly identifiable as in-kind or cash
- Source of match is clearly identified
- Budget, proposal narrative, & PPCs align
- Fiscal Agent Reviewed Prior to Submission

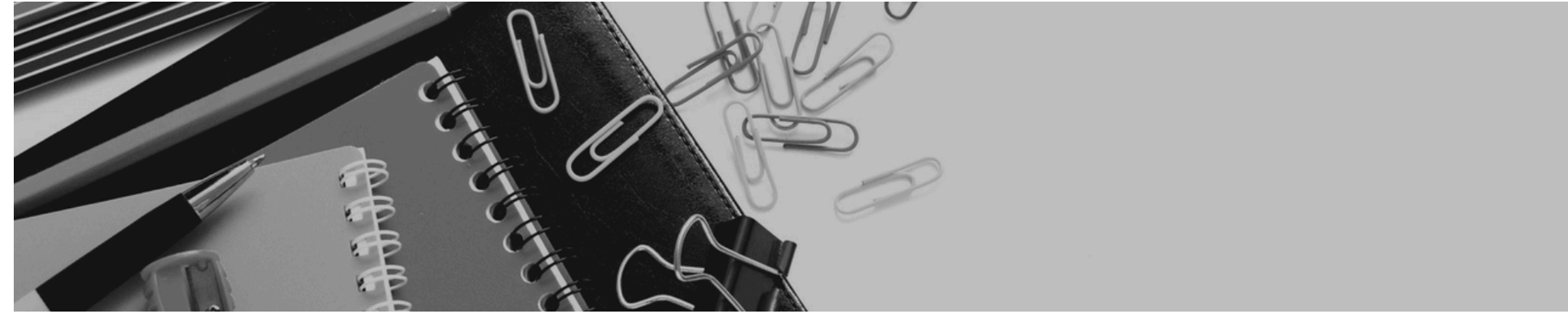
Matching Funds

Requirements & Waiver

- **Exempt:** Tribal & non-profit, non-governmental victim services organizations that are providing direct services to victims are exempt
- Not exempt, but **may request a match waiver:** Tribal & non-profit, non-governmental victim services organizations providing other services
 - Do not include match in budget form and narrative if applying for waiver
 - Provide details for the need for a waiver
- **All others must provide a match**
 - All governmental agencies must provide a match

Match Formula & Requirements

- $\text{Match} = (\text{Federal Funds Requested}) \times 0.25 \div 0.75$
- $(\$10,000 \text{ request}) \times 0.25 \div 0.75 = \$3,333 \text{ match}$
- Cash or In-Kind



Match Ideas

- Donations
- Expendable Equipment
- Office supplies, capital outlay
- Work space
- Operations
- Monetary value of time contributed by staff or volunteers if the services they provide are a necessary part of the funded project
- **Cannot be derived from federal funds**



Certification of Consultation

Applies to All Applicants

- Must consult with victim services programs **during the development of the proposal**
- **Dates & content meetings with at least 2 agencies**
- Complete form and sign (authorized)
- Governmental agencies must certify that they collaborated with non-governmental victim services providers in the planning process

Meaningful Collaboration

- Demonstrate that collaborative agencies have been involved in the planning process
- Resource sharing for mutual gain
- Increased coordination of services
- Mutual commitments
- Demonstrates a partnership between organizations
- Addresses the problem by involving all that might play a part in developing and implementing a solution



Additional Documentation



Job Descriptions, Contracts, Resumes

- Current **Job Descriptions** for proposed federal and match positions
- Actual or proposed **contracts** with contractual consultants. Drafts of contract required
- If applicable, **resumes** of candidates. If the match positions are already filled, provide the resume

Required Federal Forms

- **Assurances**
- **Certifications**
- **Disclosure of Lobbying Activities**

Other Required Documents

- Most recent **agency audit** must be included in proposal, even if CVRC has it on file
- **Agency Budget:** Current, Receivables, Expenditures
- **Policy on Determination of Suitability to Interact with Minors**
- **VAWA Staff Spreadsheet**
 - Breakdown of all funded & match VAWA staff
 - Allocation of total salary across funding sources

Required 501(c)(3) Documents

- **501(c)(3) Proof**
- **Articles of Incorporation**
- **Current list of Board Members**
 - *Contact Information*
 - *Occupation*
 - *Term information*

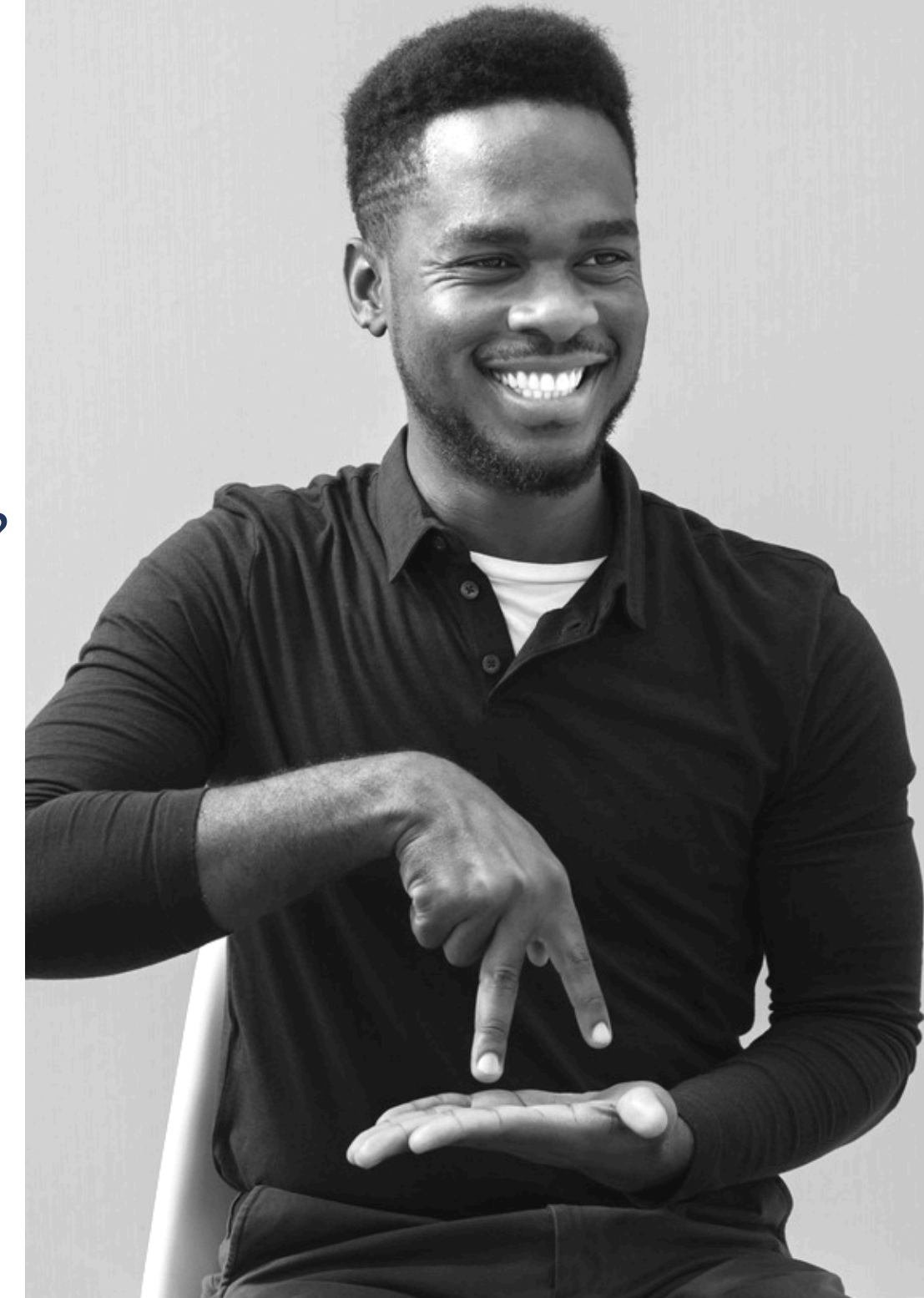
Limited English Proficiency Plan

Mandatory

- All recipients of federal funds that are providing services to individuals must have a comprehensive plan in place
- Must provide meaningful access to resources and services
- Reasonable costs associated with providing access should be in budget
- Must meaningfully address access to programs, services, and information to persons who are Deaf and hard of hearing and individuals with disabilities

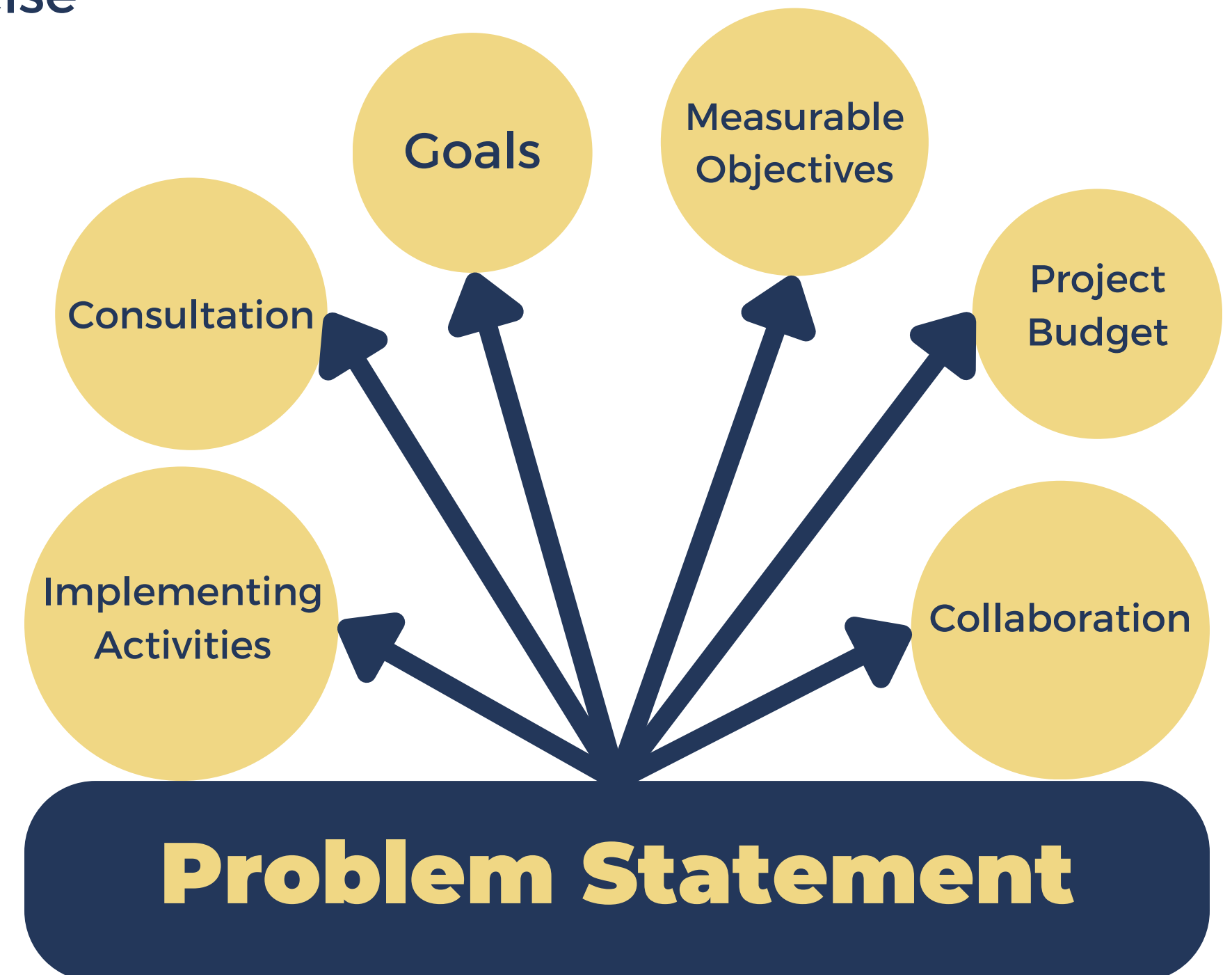
Provide responses to the following

- What is your org's process for ID'ing LEP persons who need language assistance?
- **Provide the percentage of LEP persons within your organization's eligible service population**
- What frequency do LEP individuals come into contact with the program?
- What resources are available to LEP persons by your organization? What language assistance resources are available?
- How is or how will staff be trained to serve LEP individuals?
- What is the status of LEP policy development within your organization?
- How do you provide information about your services to LEP persons?



Building Your Proposal

1. Carefully read RFP packet
2. Keep the proposal simple, clear & concise
 - a. Choose a Priority
 - b. Develop Narrative
 - c. Build Primary Project Components
 - d. Establish Project Budget
3. Build around your Problem Statement
4. Submit entire proposal on time
 - a. March 3, 2025
 - b. 4:00 PM (Mountain)
 - c. nmcvrcgrants.com
 - d. No late submissions accepted
